**ALL VENDING AND AMUSEMENT MACHINES MUST BE LICENSED PRIOR TO INSTALLATION EITHER BY VENDOR OR BUSINESS OWNER.**

**The Culver City Municipal Code provides for the payment of Business Tax fees for all coin-operated vending machines as follows:**

- Amusement machines (shooting gallery, baseball, hockey, pool tables, shuffleboard, electronic game machines\*, etc.) **\$90.00 per year per machine.**

**\*Only three (3) electronic game machines are permitted at any one location. Special permits are required for these devices.**

- Machines vending in bulk unsorted confections, nuts, gumballs, etc. or newspaper vending machine business. **\$1 per \$1,000 of Gross Receipts.**
- Machines vending any food, drink, water, other edibles or merchandise (except bulk), recycling machines, children's mechanical rides & devices, photo copy, laminating machines, juke boxes, musical devices & ATM machines. **\$18.00 per year per machine.**
- Cigarette vending machines, scales, weighing devices postage stamp machines, change machines. **\$ 3.00 per year per machine.**
