DOG LICENSE FEE EXEMPTION APPLICATION

INSTRUCTIONS

WHO IS ELIGIBLE

You may be exempt from paying the dog license fee if:

1. You are a resident of Culver City;
2. You are 60 years of age or older;
3. Your Total Adjusted Gross Income, as used for purposes of the California Personal Income Tax Law, was no more than \$18,200 for the last calendar year;

AND

The combined Adjusted Gross Income of all members of the household in which you reside was no more than \$21,500;

OR

4. You are a resident of Culver City who meets the criterion of Disability, as established by the Social Security Administration's Supplemental Security Income (SSI) Program for the Aged, Blind, and Disabled (Title XVI of the Social Security Act as amended), without regard to your age.

HOW DO YOU APPLY

If you meet the requirements stated above, you must complete the reverse side of this form, and submit the form with proof of age, utility bill with name and address, and a copy of your California Income Tax Return (if you filed one) and mail the documents to the Office of the City Treasurer, City Hall, 9770 Culver Boulevard, Culver City, CA 90232. If you are currently on Social Security Administration's Supplemental Security Income (SSI), please provide a Social Security letter stating that you are receiving SSI benefits. If you need further information, phone number is (310) 253-5865, Monday through Friday. All statements, Income Tax Returns, and any other supporting papers will be promptly returned to you.
