**LUNCH/CATERING VEHICLES**

The permit issued by the Committee on Permits and Licenses shall automatically become null and void if the person to whom the permit was issued is convicted of, or pleads guilty or no contest to, any criminal charge alleging a violation of any of the provisions of CCMC Chapter 3, Article II or Chapter 19, Article IV, of the City of Culver City, California.

NOTE: The vehicle identification number of the permitted vehicle, the current year decal number assigned to the permitted vehicle, and the person(s) designated as driver(s) of the permitted vehicle(s), shall be designated on the current business tax certificate. Each permitted vehicle must have a current year decal permanently affixed on the vehicle, at a location to be determined by the City Treasurer or the City Treasurer's designee, and the current year business tax certificate shall be carried in the permitted vehicle and shall be presented for immediate inspection upon request by a Culver City Police Officer.

**\*ADDITIONAL REQUIREMENTS FOR LUNCH/CATERING/ICE CREAM TRUCKS\***

The following documents must be submitted *with application* for approval by the Committee on Permits and Licenses:

- Original current Certificate of Insurance (\$1,000,000 minimum policy) naming City of Culver City as additionally insured
- Copy of current Health Certificate from L.A. County Health Department
