Who Is Eligible?

You may be exempt from paying the dog license fee if:

1. You are a resident of Culver City;
2. You are 60 years of age or older;
3. Your Total Adjusted Gross Income, as used for purposes of the California Personal Income Tax Law, was no more than \$18,200 for the last calendar year;

AND

The combined Adjusted Gross Income of all members of the household in which you reside was no more than \$21,500;

OR

4. You are a resident of Culver City who meets the criterion of Disability, as established by the Social Security Administration's Supplemental Security Income (SSI) Program for the Aged, Blind, and Disabled (Title XVI of the Social Security Act as amended), without regard to your age.

How Do You Apply?

If you meet the requirements for the **low-income senior citizen exemption**, send:

- Complete the first page of the form, and enclose. Be sure to sign the form!
- Enclose utility bill with name and address.
- Enclose proof of age (60+).
- Enclose a copy of your California Income Tax Return (if you filed one).

If you meet the requirements for the **low-income SSI exemption**, send:

- Complete the first page of the form, and enclose. Be sure to sign the form!
- Enclose utility bill with name and address.
- Enclose a Social Security letter stating that you are receiving SSI benefits.

For all applications, please include the following pet information:

- Enclose current rabies vaccination certificates for each pet.
- Enclose proof of spay/neuter for each pet, if applicable.
- Include each pet's microchip number (all dogs must be microchipped).
- Enclose check made out to City of Culver City if licensing more than one pet.

All statements, Income Tax Returns, and any other supporting papers will be promptly returned to you. Rabies vaccination certificates and spay/neuter certificates will not be returned.
