



**NOTICE OF PUBLIC HEARING**

THE CITY OF CULVER CITY, IN COMPLIANCE WITH ARTICLE XIID OF THE CALIFORNIA STATE CONSTITUTION AND THE PROPOSITION 218 OMNIBUS IMPLEMENTATION ACT, IS HEREBY NOTIFYING ALL AFFECTED PROPERTY OWNERS/CUSTOMERS OF THE FOLLOWING:

- The City of Culver City is proposing to increase its refuse collection rates, which have not been increased since 2015. The purpose of the proposed increase is to adequately fund the ongoing costs of providing refuse collection service to properties within the City of Culver City.
- This notice includes the proposed schedule of rates for Fiscal Year 2017/18 through 2019/2020. If the proposed rate increase is adopted by the City Council, the rates will become effective July 1, 2017 and remain in effect until otherwise modified by the City Council. The refuse rates cannot exceed the amounts adopted by the City Council without providing written notice to property owners/customers.

**COMMENTS AND WRITTEN PROTEST**

A Public Hearing on the proposed refuse collection rate increase will be held on July 24, 2017, at 7:00 pm, or as soon thereafter as the matter may be heard, in the City Council Chambers located at 9770 Culver Boulevard in the City of Culver City. The City Council will hear and consider all oral and written testimony concerning the proposed refuse collection rates.

**Any property owner or customer may submit a written protest to the proposed increase to the refuse rates; provided, however, only one protest will be counted per identified parcel. Each protest must (1) be in writing; (2) state that the identified property owner or customer is in opposition to the proposed refuse rates; (3) provide the location of the identified parcels (by assessor's parcel number or street address); and (4) include the signature of the property owner or customer submitting the protest. Protests submitted by e-mail, facsimile, or other electronic means will not be accepted. Written protests may be submitted by mail to the City Clerk, or at the Public Hearing, so long as they are received prior to the conclusion of the Public Hearing. Please identify on the front of the envelope for any protest, whether mailed or submitted in-person to the City Clerk, that the enclosed letter is for the Public Hearing on the Proposed Refuse Rate Increase.**

Written protests will be tabulated pursuant to procedures adopted by the City Council. If, at the close of the Public Hearing, written protests against the proposed increase to the refuse rates are not presented by a majority (50% plus 1) of property owners/customers of the identified parcels upon which they are proposed to be imposed, the City Council will be authorized to adopt the rates.
