A RESOLUTION OF THE CITY COUNCIL OF THE CITY CULVER CITY, CALIFORNIA. **ADOPTING PROCEDURES** AND REGULATIONS **FOR** RESIDENTIAL PERMIT PARKING DISTRICTS AND RELATED PROGRAM FEES AND RESCINDING RESOLUTION NO. 2012-R024.

WHEREAS, pursuant to Vehicle Code Section 22507 and Culver City Municipal Code Section 7.03.300, et seq., the Procedures and Regulations for Residential Permit Parking Districts (the "Program"), attached hereto as Exhibit "A", are hereby approved and adopted. The Engineering Division shall have authority to promulgate and administer procedures and regulations implementing residential permit parking districts, the issuance of preferential parking permits, and the collection of fees for such permits; and

WHEREAS, the Program addresses the community's needs for available parking supply in the public right-of-way and balances those needs with the Public Works Director's/City Engineer's responsibility to manage parking, traffic, and the public right-of-way, and the Police Chief's responsibility to enforce parking violations;

WHEREAS, on September 18, 2013, at a duly noticed public meeting, the Traffic Committee discussed the proposed Program and received community input; and

WHEREAS, on September 21, 2013, at a duly noticed community meeting, the Engineering Division presented the proposed Program and received community input; and

WHEREAS, at the duly noticed public meetings of September 23 and November 12, 2013, after giving the public an opportunity to be heard and considering all information before it, the City Council adopted the Program procedures and regulations, and related fees, attached to this Resolution as Exhibits "A" and "B," respectively; and

WHEREAS, the fees established herein are based upon the reasonable cost of providing the services and regulatory activity for administering the Program.

NOW, THEREFORE, the City Council of the City of Culver City, California DOES HEREBY RESOLVE as follows:

- 1. The Procedures and Regulations for Residential Permit Parking Districts, attached to this Resolution as Exhibit "A" and incorporated herein by this reference, are hereby approved and adopted and shall be effective on the date of the adoption of this Resolution.
- 2. The Procedures and Regulations for Residential Permit Parking Districts Fees, attached to this Resolution as Exhibit "B" and incorporated herein by this reference, are hereby adopted and shall be effective on the date of the adoption of this Resolution.
- 3. Each of the City's existing preferential parking zones shall be included within one of the newly created Residential Parking Districts in accordance with the adopted Procedures and Regulations for Residential Permit Parking Districts.
