How do I protect myself and my co-workers?

Protect yourself and others by taking precautions such as:

- Monitor for symptoms (e.g., fever, cough, shortness of breath, flu-like symptoms) before going to work.
- Stay home when you are sick or feeling unwell.
- Wash your hands frequently with warm, soapy water for at least 20 seconds; use a hand sanitizer if soap and water are not readily available.
- Wear a face covering when you are in a shared space or may encounter another person.
- Practice physical distancing (i.e., stay at least 6 ft from other employees and customers when possible).
- Talk with your employer about other infection control protocols that need to be followed.

What happens if I don't feel well or am sick?

If you feel sick, stay home. Call **2-1-1** or your medical provider to discuss your symptoms and determine whether you should get tested for COVID-19. Let your employer know you feel unwell and are seeking a medical diagnosis. Check with your employer to see if you are eligible to receive paid time away per the FFCRA or other paid

You may also be eligible for paid time off under the Families First Coronavirus Act (FFCRA) expanded Family Medical Leave Act. How am I protected at work?

Employers are required to comply with reopening protocols outlined by the Los Angeles County Department of Public Health to ensure a safe worksite for employees. Protocols include, but are not limited to:

- Conducting symptom checks before entering the workplace
- Providing no-cost face coverings when in the presence of other employees or customers
- Allowing time for frequent hand washing
- Designating employee accessible locations for hand sanitizer and other cleaning supplies
- Designating employee break areas and times to ensure 6 feet physical distancing.

Employers are required to share the reopening protocols with all employees so that employees understand safety procedures and requirements. Additionally, workers are to be provided information on employer or government-sponsored leave benefits (e.g., the Families First Coronavirus Response Act (FFCRA), which applies to employers with less than 500 employees and for those employees that need to stay home due to a COVID-19 illness or impact or to care for a child whose school, care center or provider is unavailable due to COVID-19 related reasons.
