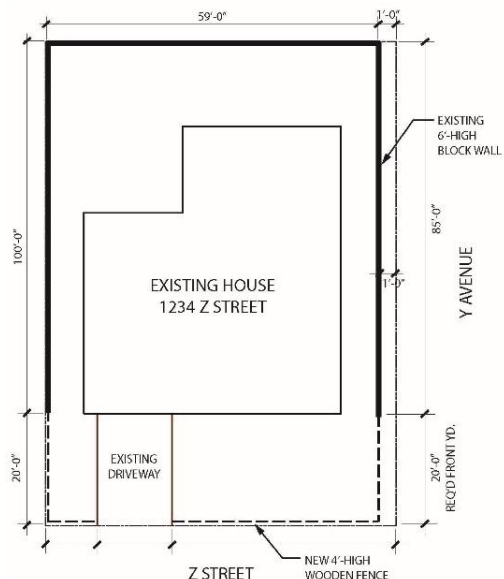
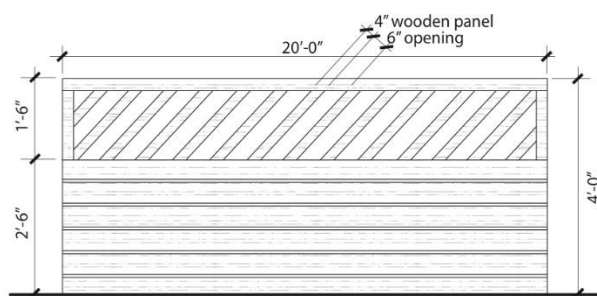

- ☐ Neighbor's Affidavit – Required if any portion of the fence is located on neighbor's property (see attached).

• SUMMARY OF STANDARDS (CCMC 17.300.030):

Location	Max. Height	Additional Requirements
Required front setback area	4 feet	For the portion within 10 feet of a street, the portion above 30 inches in height shall be of an openwork design (e.g. lattice, wrought iron, etc.) to ensure adequate visibility.
Required side and rear setback area	6 feet	If adjacent to street, a minimum 1-foot landscaped setback is required.
Within 15 ft. of intersection or 5 ft. of driveway	4 feet	The portion above 30 inches in height shall be of an openwork design to ensure adequate visibility.

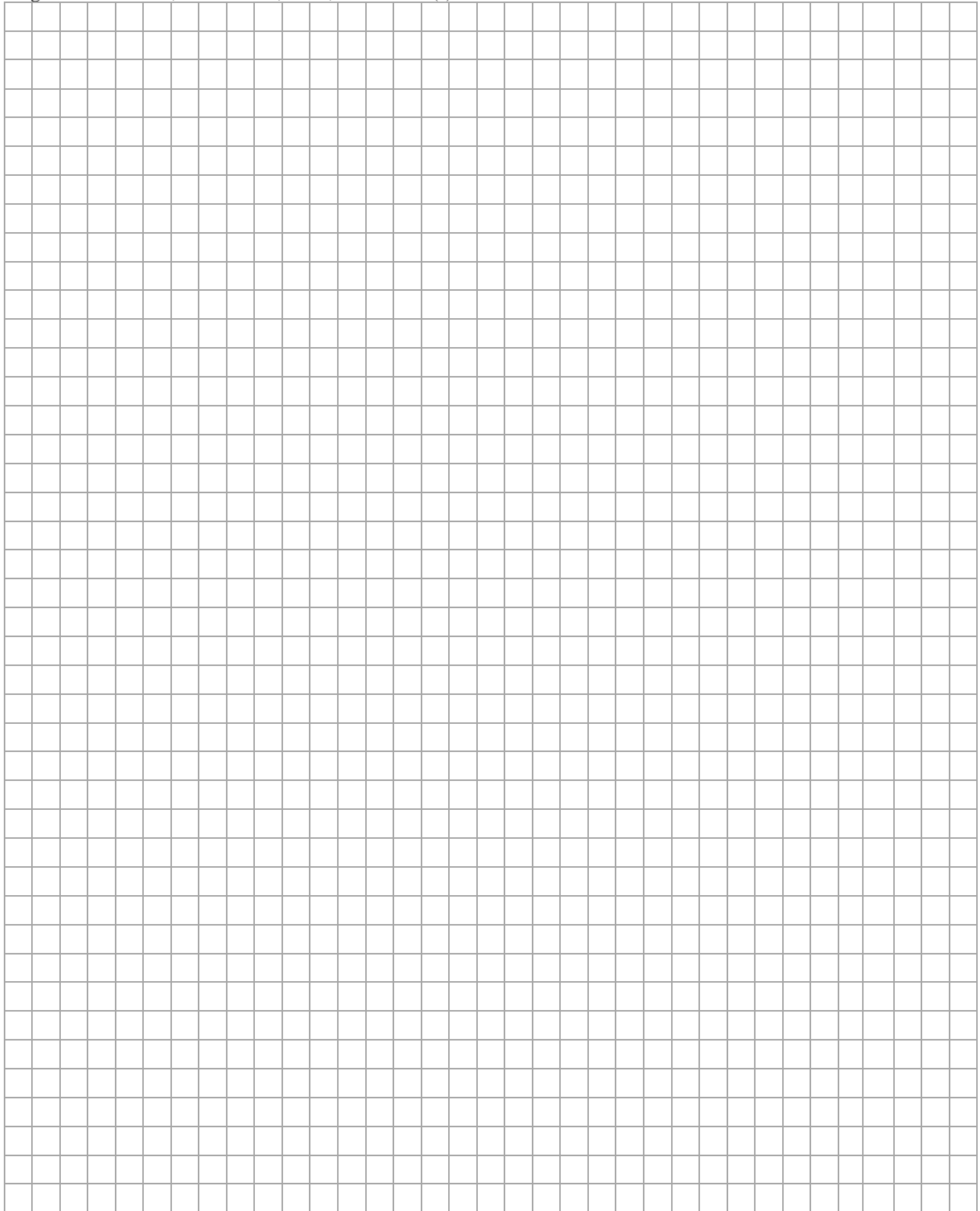
Note: Any fence, wall or hedge may be limited to 4 feet for safety sightline purposes as deemed necessary and appropriate by the Director.
