### Rental Category

**"Non-Profit, Resident/Government,"** shall mean any 501(c)(3) Non-Profit Organization that is headquartered in the of Culver City. Culver City 501(c)(3) Non-Profit Organization, annually, shall submit a copy of its current IRS Form 990 (no older than 2 years) to be placed on file with the PRCS Department as as its General Liability Insurance with corresponding Culver City headquarters address.

**"Non-Profit, Non-Resident"** shall mean any 501(c)(3) Non-Profit Organization that is not headquartered the City of Culver City. Non-Resident 501(c)(3) Non-Profit Organization, annually, shall submit a copy of most current IRS Form 990 (no older than 2 years) to be placed on file with the PRCS as well as its General Liability Insurance with corresponding headquarters address

**"Private Party, Resident"** shall mean any City of Culver City resident holding a private gathering. qualify as a resident, renter shall submit a copy of his/her most current utility bill (no older than 2 months) provide a secondary proof of residency with photo identification. Private Parties are events organized by only, and no admission is charged, no public marketing has occurred, no business or services are being provided.

**"Private Party, Non-Resident"** shall mean anyone residing outside of the City of Culver City holding private event. Private Parties are events organized by invitation only, and no admission is charged, public marketing has occurred, no business or services are being provided.

**"Commercial, Resident,"** shall mean any business headquartered in the City of Culver City or group that does not qualify under Categories A-E whether for monetary gain or not. as "Commercial, Resident", renter shall submit a copy of his/her valid Culver City Business Tax Certificate. Any person or group in this category shall prove residency using any method found in Category B or Any person, group or business in this category shall submit General with a corresponding Culver City address.

**"Commercial, Non-Resident,"** shall mean any business not headquartered in the City of Culver City any person or group that does not qualify under Categories A-E, whether for monetary gain or not and is not a resident of the City of Culver City. Anyone person, group or business in this category shall submit their General Liability Insurance. Commercial renters are required to obtain a Culver City Business Tax Certificate if they are charging admission for classes, presentataions or special events.
